### 4. FIRST AID MEASURES

**First aid measures**

<b>General advice</b>	Immediate medical attention is required.
<b>Skin Contact</b>	Immediate medical attention is required. Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes.
<b>Eye contact</b>	Immediate medical attention is required. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Keep eye wide open while rinsing. Do not rub affected area.
<b>Inhalation</b>	Remove to fresh air. Call a physician or poison control center immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.
<b>Ingestion</b>	Immediate medical attention is required. Do NOT induce vomiting. Drink plenty of water. Never give anything by mouth to an unconscious person. Remove from exposure, lie down. **Note to physicians** Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.

## 5. FIRE-FIGHTING MEASURES

**Suitable extinguishing media**
