4. FIRST AID MEASURES

First aid measures

General advice Immediate medical attention is required.

Skin Contact Immediate medical attention is required. Wash off immediately with soap and plenty of

water while removing all contaminated clothes and shoes. For minor skin contact, avoid spreading material on unaffected skin. For severe burns, immediate medical attention is

Eye contact Immediate medical attention is required. Rinse immediately with plenty of water, also under
