**4. FIRST AID MEASURES**

**First aid measures**

**General advice** Immediate medical attention is required.

**Skin Contact** Immediate medical attention is required. Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. For minor skin contact, avoid spreading material on unaffected skin. For severe burns, immediate medical attention is required.

**Eye contact** Immediate medical attention is required Rinse immediately with plenty of water, also under

the eyelids, for at least 15 minutes Keep eye wide open while rinsing Do not rub affected area Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes

<b>Inhalation</b>	Remove to fresh air. Call a physician or poison control center immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.
<b>Ingestion</b>	Immediate medical attention is required. Do NOT induce vomiting. Drink plenty of water. Never give anything by mouth to an unconscious person. Remove from exposure, lie down. Clean mouth with water and drink afterwards plenty of water. Call a physician or poison control center immediately.
<b>Self-protection of the first aider</b>	Use personal protective equipment as required. Avoid contact with skin, eyes or clothing.

#### **Most important symptoms and effects, both acute and delayed**

**Symptoms** No Information available.

#### **Indication of any immediate medical attention and special treatment needed**

**Note to physicians** Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.

## **5. FIRE-FIGHTING MEASURES**

#### **Suitable extinguishing media**

Use extinguishing measures that are appropriate to local circumstances and the surrounding environment.

#### **Specific hazards arising from the chemical**

The product causes burns of eyes, skin and mucous membranes. Thermal decomposition can lead to release of irritating and toxic gases and vapors. In the event of fire and/or explosion do not breathe fumes.
